Sexual Harassment and Abuse Coverage Cobertura para Abuso y Acoso Sexual

1. At the past Joint Bishops Meeting on March 21, 2023, President Salazar announced an investigation to confirm that all churches and missions have liability coverage for sexual abuse and harassment. At the end of June this task was assigned to the General Secretariat. Sister Lydia Hernandez conducted this investigation in July and August. She found that 80 churches had uploaded their information on ARIS.

1. En la pasada Reunión Conjunta, el día 21 de marzo del 2023, el Presidente Salazar anunció una investigación para confirmar que todas las iglesias y misiones cuenten con cobertura de responsabilidad por abuso sexual y acoso. A fines de junio esta tarea se asignó a la Secretaría General. Nuestra hermana Lydia Hernández realizó esta investigación en julio y agosto. Solo encontró información de 80 iglesias en ARIS.

2. The General Board of Directors and the Legal Counsel of the Apostolic Assembly request that all insurance policies for our churches be for a minimum of \$500,000.00 (five hundred thousand), for the liability coverage of sexual abuse, inappropriate sexual behavior and negligence.

2. La Mesa Directiva General y el Consejero Legal de la Asamblea Apostólica solicitan que todas las pólizas de seguro de nuestras iglesias tengan una cobertura mínima por \$ 500,000.00 (quinientos mil dólares), en los conceptos de Cobertura de Responsabilidad por Abuso Sexual Infantil, Acoso Sexual, Conducta Sexual Inapropiada o Falla en Reportar los anteriores tres casos.

3. Brotherhood Mutual, the insurance company that provides our insurance policy at Headquarters, has also just recommended that our churches increase their protection for sexual abuse and harassment to \$500,00 and \$1,000,000 for larger churches.

3. La compañía de seguro Brotherhood Mutual, que provee la póliza para las oficinas generales, acaba de recomendar que nuestras iglesias incrementen su protección contra acoso y abuso sexual a \$500,000, y que nuestras iglesias mas grandes lo incrementen a \$1,000,000.
